**Re: Election Office Case No. P-036-LU722-SCE**

Gentlemen

A pre-election protest was filed by Dan Hanners and Mark Serafinn under Article XI of the Rules for the IBT International Union delegate and Officer Election, revised August 1, 1990 ("Election Rules") In their protest, which was received by the Election Office on November 6, 1990, the complainants allege that their rights under the Election Rules were violated as a result of their failure to received a copy of the approved Local Union election plan and the failure of the Local Union to post a summary of the plan on Local Union bulletin boards The Election Officer's investigation revealed the following facts

The approved Local Union election plan was transmitted by the Election Office Regional Coordinator to the Local Union by overnight letter dated October 31, 1990 Copies of the approved plan were transmitted to the complainants by the Regional Coordinator after the receipt of their protest Eighty copies of the summary of the Local Union election plan were posted on Local Union bulletin boards on November 7, 1990 Twenty-two additional copies of the summary were mailed on November 7, 1990 to shop stewards for posting at remote bulletin boards


Article II, Section 2(d) of the Election Rules provides that, upon request to the Election Officer, a copy of the approved Local Union election plan will be made available to any member of the Local Union That Section of the Election Rules also requires the Local Union to post a summary of the approved Local Union election plan to be posted on all Local Union bulletin boards with 7 days of the plans approval by the

Election Officer Based upon the forgoing facts, it appears that these requirements of the Election Rules have been complied with in this case The protest will therefore be denied

If any interested party is not satisfied with this determination, they may request a hearing before the Independent Administrator within twenty-four (24) hours of their receipt of this letter. The parties are reminded that, absent extraordinary circumstances, no party may rely upon evidence that was not presented to the Office of the Election Officer in any such appeal Requests for a hearing shall be made in writing, and shall be served on Independent Administrator Frederick B. Lacey at LeBoeuf, Lamb, Leiby & MacRae, One Gateway Center, Newark, New Jersey 07102-5311, Facsimile (201) 622-6693 Copies of the request for hearing must be served on the parties listed above, as well as upon the Election Officer, IBT, 25 Louisiana Avenue, N W , Washington, D C 20001, Facsimile (202) 624-8792. A copy of the protest must accompany the request for a hearing
