The complainant filed a pre-election protest pursuant to Article XI, Section 1 of the *Rules for the IBT International Union Delegate and Officer Election*, revised August 1, 1990 ("*Rules*") The complainant Aurora Rodriguez alleged that the Local Union office refused to allow her to use the fax machine of the Local to transmit to the Election Officer pre-election protests and/or information requested by the Election Officer with respect to such protests


On the basis of the foregoing, the Election Officer considers this protest to be **RESOLVED**

Requests for a hearing shall be made in writing, and shall be served on Independent Administrator Frederick B. Copies of the request for hearing must be served on the parties listed above, as well as upon the Election Officer, IBT, 25 Louisiana Avenue, N W, Washington, D C. 20001, Facsimile (202) 624-8792. A copy of the protest must accompany the request for a hearing.
