A pre-election protest was filed pursuant to Article XI, Section 1 of the *Rules for the IBT International Union Delegate and Officer Election*, revised August 1, 1990 ("*Rules*") The complainant, Tom Henry, protests that Local Union 788 wrongfully designated the "Rank & File Reform Slate" as the "Henry/Bell Slate" on the notice of nominated candidates which was posted in the shops This designation was contrary to the slate name shown on the declaration form filed on behalf of the slate

On the direction of the Regional Coordinator, the Local Union agreed to and did post a revised notice of the Results of the Nomination Meeting containing the correct slate name


On the basis of this corrective action having being taken, the protest is considered **RESOLVED**

If any interested party is not satisfied with this determination, they may request a hearing before the Independent Administrator within twenty-four (24) hours of their receipt of this letter The parties are reminded that, absent extraordinary circumstances, no party may rely upon evidence that was not presented to the Office of the Election Officer in any such appeal Requests for a hearing shall be made in writing, and shall be served on Independent Administrator Frederick B Lacey at LeBoeuf, Lamb, Leiby & MacRae, One Gateway Center, Newark, New Jersey 07102-5311, Facsimile (201) 622-6693 Copies of the request for hearing must be served on the parties listed above,
