Mesdames and Mr. Simpson:

A protest was filed pursuant to the *Rules for the IBT International Union Delegate and Officer Election*, revised August 1, 1990 ("*Rules*"), a copy of which is enclosed. The protest was filed by Patricia McIntosh and Doris Williams, both certified delegates to the 1991 IBT International Union Convention from Local Union 743. They contend that Local Union 743 has violated the *Rules* by failing to provide them, and the other delegates from Local 743, with reasonable per diem expenses and further for refusing to permit the cost of car rental to be considered an appropriate per diem expense.

The Local has informed the Election Officer that it has and will provide its delegates with expense advances in the amount of \$130.00 per day. Further, Local 743 has indicated that such expense advances may



be used for all Convention-related expenses, including -- if appropriate -- rental of cars. Thus, this protest is resolved.

If any interested party is not satisfied with this determination, they may request a hearing before the Independent Administrator within twenty-four (24) hours of their receipt of this letter. The parties are reminded that, absent extraordinary circumstances, no party may rely upon evidence that was not presented to the Office of the Election Officer in any such appeal. Requests for a hearing shall be made in writing, and shall be served on Independent Administrator Frederick B. Lacey at LeBoeuf, Lamb, Leiby & MacRae, One Gateway Center, Newark, New Jersey 07102-5311, Facsimile (201) 622-6693. Copies of the request for hearing must be served on the parties listed above, as well as upon the Election Officer, IBT, 25 Louisiana Avenue, N.W., Washington, D. C. 20001, Facsimile (202) 624-8792. A copy of the protest must accompany the request for a hearing.
