Re: Election Office Case No. P-872-IBT

Gentlemen:

A protest was filed pursuant to the *Rules for the IBT International Union Delegate and Officer Election*, revised August 1, 1990 ("*Rules*") by Chris Scott on his own behalf as a member of the IBT and on behalf of the Durham Unity Team. The protest contends that the Eastern Conference Black Caucus meeting on May 11, 1991 violated the *Rules* in that Union funds were utilized to promote candidate(s) for IBT International Union office.

The focus of Mr. Scott's protest appears to be that Union funds were allegedly utilized to promote the candidacy of Eddie Kornegay, a candidate for International Union Trustee. The election for Trustees of the International Union has been concluded. The Election Officer has certified the results of such election. Mr. Kornegay was unsuccessful in his attempt to be elected as an International Union Trustee.

Mr. Scott has now indicated to the Election Officer that he seeks to withdraw his protest. The Election Officer, finding that such withdrawal effectuates the purposes of the *Rules*, permits the protest to be WITHDRAWN.
