Seasonal Elections: Any local union in which ten percent (10%) or more the membership is employed by a seasonal food industry. These Local Unions will be notified by the Election Supervisor of their seasonal status.

Fall Elections: Any local with a regularly scheduled local union officer election in the fall of 2020 may choose to hold a fall delegate and alternate delegate election. If the Local Union chooses to elect delegates in the fall, the Local Union Plan must be submitted on or before June 30, 2020. Any local that does not submit its plan by this date shall be required to conduct delegate nominations and elections during the winter and spring of 2021.

If the Local Union chooses to hold delegate and alternate elections in the fall of 2020, the delegate and alternate delegate nominations and elections must be conducted entirely separate from the Local Union's officer elections. Contact the Election Supervisor or the Regional Director at the address listed above with any questions regarding how to conduct separate delegate and officer nominations and elections.

Winter/Spring Election: All other local unions shall submit a Local Union Plan on or before September 30, 2020. A local union that does not submit a plan by this date will have to conduct its delegate election according to a plan imposed by the Election Supervisor. The cost of planning and conducting the election will be the responsibility of the local union.

Please follow the instructions of the on-line LUEP form and provide the information that the LUEP system will use to generate the Local Union election plan.

Section 1. Responsibility to Conduct the Election

All elections must be conducted by mail ballot in accordance with the Rules. Ballots can be counted by hand or by mechanical device. Each local union has the option of either conducting its own delegate nomination and election, or hiring an outside agency to conduct the election.

A local union that chooses to conduct the nomination and election process without an outside agency has two options:

- Appoint an election committee (check local by-laws to see if this is required). Each candidate for
 office may designate one member of the local for service on the local union election committee, who
 shall be appointed by the President or Secretary-Treasurer.
- Permit the local executive board to conduct the election. If this option is chosen, any local union officer or member who intends to seek nomination for delegate or alternate delegate, or who is a candidate for either position may not serve on the local union election committee and may not conduct the nomination or election of delegates or alternate delegates.

The nomination period for fall delegate and alternate delegate nominations is September 1, 2020 – November 7, 2020

Local unions that do not have a regularly scheduled local union officer election in the fall of 2020 must hold the Convention delegate and alternate delegate nomination(s) meeting between January 4, 2021 and March 7, 2021.

The IBT Constitution provides that members of the local union who are in arrears in the payment of their dues can pay their arrearage in order to be eligible to participate in the election. Election Day must be scheduled on a date that the post office is open for business and the local union is able to pick up the voted ballots returned for counting. Ballots should be picked up from the post office after 9:00 a.m. on Election Day. The ballot count should start at or after 10:00 a.m.

Fail Election Time Period; The election time period for fall delegate and alternate delegate elections is October 24, 2020—December 31, 2020.

Winter/Spring Election Time Period: The election period for winter/spring delegate and alternate delegate elections is February 27, 2021—April 30, 2021.

On Election Day, voted ballots should be retrieved from the post office box where they have accumulated and brought back, unopened, to the count site. The general procedure recommended for the ballot count uses these steps:

- The Election Committee puts all the envelopes in alphabetical order, according to the return address label bearing the voter's name.
- For each returned envelope, compare the voter's name to the voter eligibility list.
- If the voter is eligible, place the unopened envelope in a container marked "Eligible." If the voter's eligibility is in doubt, mark the outside of the envelope with the letter "C" for "Challenged" and place it in a separate container labeler "Challenged."
- Continue until all the return envelopes have been compared to the voter eligibility list.
- Open all the outer return envelopes in the "Eligible" grouping. Extract the Secret Ballot Sleeve or Envelope, and separate them from the outer return envelopes. Do not remove the ballots or open the Secret Ballot Envelopes at this step.
- After separating the outer return envelopes from the Secret Ballot Sleeve or Envelope, and otherwise
 preserving the secrecy of each voter, remove the ballots from the Secret Ballot Sleeves or Envelopes.
- The Election Supervisor recommends, but does not require, using a mechanical device to count ballots, and the local union may determine to count ballots manually.
- If ballots are counted manually, the ballots must be tallied at least two times. The procedure recommended for a manual count uses these steps:
- Separate the ballots into three stacks for counting as follows:
 - 1. The voter chose a full slate of candidates.
 - 2. The voter chose a partial slate of candidates.
 - 3. The voter chose only individual candidates.

After sorting, count each stack of ballots in groups of fifty (50) ballots.

When the tally of ballots initially determined to be Eligible is complete, count the number of envelopes in the "Challenged" container. If the number of challenged ballots could affect the outcome of any contest, the Election Committee should immediately recess the count and contact the Election Supervisor's Regional Director without attempting to resolve eligibility challenges. The Office of the Election Supervisor is solely responsible for resolving the eligibility of voters who cast challenged ballots.

Election Supervisor's Memorandum Regarding Comments on IBT Local Union 222 Election Plan

The 2021 Election Rules require each IBT local union to conduct an election for International Convention delegates at the local's expense, and to propose a Local Union Election Plan ("LUEP") for the election. Article II Sections 1 and 4(a). The Election Supervisor is authorized to "supervise," but not directly conduct, the delegate elections. Article II, Section 1. The 2021 Election Rules require the Election Supervisor to review and approve LUEPs making modifications as appropriate. Article II, Section 4(a). Members are notified by posting when a local union submits a LUEP, and "[a]ny interested Union member" may submit comments within fifteen days of a plan's submission to the Office of the Election Supervisor ("OES").

On August 20, 2020, IBT Local Union 222 submitted an LUEP for conducting its 2020-2021 election for International Union Delegates and Alternate Delegates. On September 1, 2020, Dale Varney, a member of Local Union 222, submitted comments on the LUEP to the OES Regional Director. The five specific comments may be summarized as follows:

- 1) Varney objects to the date selected for conducting the nomination meeting; and
- 2) Varney objects to the local union's engagement of a third-party service to conduct the election.

We have considered Varney's comments, Local Union 222's response to the comments, relevant portions of the local union bylaws, the 2021 Election Rules, and evidence of the local union's past practices. Based on that material and for the reasons that follow, we conclude that the local union's proposals with respect to the nominations meeting date and the use of a third-party election vendor comply with the 2021 Election Rules and are reasonable.

Local Union 222, headquartered in Salt Lake City, Utah, had a 24-month rolling average of 3,676 members as of November 30, 2019, and the preliminary delegate strength for the local union is set at 5 delegates. The local's LUEP proposes to conduct the nominations meeting in the early evening on Monday, January 11, 2021. Notice of the meeting is to be printed in the "Rocky Mountain Teamster Newsletter" mailed to members the preceding month.

The LUEP proposes to use a third-party vendor, TrueBallot, of Bethesda, Maryland, to conduct the nominations meeting and the election. Local Union 222's 2015 and 2010 LUEPs also proposed to use a third-party vendor (a vendor other than TrueBallot) to conduct the election. In the 2015-2016 IBT International officer election cycle, eleven different local unions identified TrueBallot as the vendor to conduct their delegate elections.

Regarding Comments to IBT Local Union 222 Local Union Election Plan September 16, 2020 Page 2

We address Varney's comments in the order he stated them.

 If this Local is to be held to its own rules set forth to govern it, under Section 16(A) of these Local Union Bylaws, then the nominations meeting would be held on a Saturday mid-afternoon. The majority of the members in this local work Monday-Friday; the mid-afternoon part accommodates those members who are working the graveyard shift Friday night.

Section 16(A) of the Local Union 222 bylaws provides that nominations for local union officers shall be at "such time and place" as "shall be convenient to the greatest attendance by all the members." This provision by its terms applies only to the local union's officers nominations and not to the delegates election. But even if this provision were applied to delegate nominations, the bylaw does not prescribe a particular date or time on which the nominations meeting must be held.

As noted, the LUEP proposes to hold the nominations meeting on Monday, January 11, 2021 at 6:00 pm. Responding to Varney's comment, Local Union 222 observed that the time set in the LUEP is convenient for large segments of the membership (composed of freight drivers, UPS workers, and bakery/dairy workers), and that the last officer nominations meeting (also held on a Monday at 6:00 p.m.) produced "more participation than at any of our General Membership meeting in over the last two years." The date selected for the nominations meeting complies with the 2021 Election Rules and appears reasonably calculated to allow those who choose to participate in person an opportunity to do so.

The 2021 Election Rules allow candidates for delegate and alternate delegate to be nominated in writing and to accept nomination in writing without attending the meeting in person. Article II, Sections 5(t) and 5(l). In light of the ongoing coronavirus pandemic, written nominations and acceptances are strongly encouraged in the current election cycle, and Local Union 222's LUEP facilitates the submission of such writings by email. Thus, even a member unable to attend the January 11, 2021 meeting in person will be able to participate fully in the nomination process.

2) If it's a matter of timeliness, with regards to the notice, then pushing the meeting back 2 days to that Saturday, January 9th, 2021 should also be well within the time needed, as set forth in Article 2 Section 5(a).

Varney notes that the nominations meeting would be timely under the 2021 Election Rules if were held two days earlier than in the LUEP. The 2021 Election Rules do not require the meeting to be held at the earliest possible date after the nominations notice, and we have already concluded that the January 11th date is reasonable. That the nominations meeting could be held earlier does not require a change.

 Currently there is a petition in this local to change the date and time of our General Membership Meetings to Saturdays at 10am that Brother Hogue is well aware of. www.change.org/222changethedate Regarding Comments to IBT Local Union 222 Local Union Election Plan September 16, 2020 Page 3

As of September 15, the petition website reflected 28 electronic "signatures," constituting less than 1% of the Local Union 222 membership (assuming the signers are all members). This petition does not provide a basis to question the reasonableness of the Monday evening nominations meeting.

4) The use of an "Election Service" and cost associated with it, I believe, will be used to coerce members running for Delegates and Alternates Delegates for the opposing side to fall in line, so as to not "cost the local this unneeded expense." This is not just my belief, this has actually played out with Brother Hogue, and members of his slate, with the opposing slate running against them in this local's last election. See attached statement from Tony Winters, dated Wednesday, September 2nd, 2020. In accordance with Article 5(h) of these Election Rules we feel that this is likely to happen again. This Local has been successful in holding mail-in ballot elections for Shop Stewards in accordance with its own Bylaws, Section 12, and I see no reason the same can't be done for the election of Delegates and Alternate Delegates for this IBT Convention.

Local Union 222's LUEPs for 2011 and 2016 designated a third-party vendor to conduct the delegates elections and has used a third-party vendor to conduct its officers election in 2019. The local notes that if the delegates election is contested, conducting the election across the entire membership is a different proposition from shop steward elections among much smaller subsets of employees. Many local unions engage vendors to conduct their delegates elections as opposed to re-directing local union staff to perform the function, and this particular vendor is among those selected by other local unions. The decision to use a third-party vendor, which the local represents is well within its current finances, is within the local's discretion.

5) There has been a very large, and not at all subtle, movement for the OZ Slate in this Local, Brother Hogue is backing the Power Slate; the opportunity for Brother Hogue to reach out to any lead members behind the organizing effort of the OZ Slate to coordinate a time the we could go over an election plan before it was submitted was absolutely a possibility. In accordance with Article 2 Section 3(c) Spencer Hogue was notified "on or about June 1st, 2020" with the number of Delegates to be elected by the members of this local, which would have given him more than enough time to set a meeting to discuss dates and times, and the use of an election service. Which would have avoided this exact situation from playing out.

This comment reflects that Varney would have preferred an opportunity to discuss aspects of the LUEP before Local Union 222 submitted it. He received an opportunity to comment on the LUEP, however, as the 2021 Election Rules provide, and exercised his right to do so. Secretary-Treasurer Hogue disputes Varney's description of political alignments on the local union board. Any such dispute, however, is beyond the scope of the specifics of the Local Union 222 LUEP or the 2021 Election Rules. Members remain free to organize and campaign for candidates of their choice and may elect to protest improper interference with those rights.

On August 20th 2020 a Local Union Election Plan was submitted to the office of the IBT Election Supervisor by our Local Unions Principale Officer/Secretary Treasurer/UPS Feeder Business Agent Spencer Hogue for approval. In the Election Plan submitted under Section 3(a) Spencer Hogue has indicated that Local 222 will only be having 1 Nomination Meeting, and in Section 3(b) that meeting will be held on Monday, January 11th, 2021, Brother Hogue gives the reasoning behind this decision as a result of our General Membership Meeting not falling in line with the 21 days needed to mail the notice, along with having to take the outside election services schedule into consideration.

The reason for these comments about to be stated in accordance with the 2020-2021 IBT Election Rules Article 2 Section 4(d) is for the purpose of ensuring that this Local is allowing the opportunity for the majority of its membership to be able to be present, and participate in the function of their union, as per its own Bylaws regarding Elections. See Section 16(A) of these Local Unions Bylaws, "The Executive Board shall set the time and place of nominations and elections and such time and place and other relevant shall be convenient to the greatest attendance by all the members." In addition to the meeting date and time, the use of an "Election Service" is a costly service for a local in a Right-to-Work state. This gesture of goodwill, efficiency, and security in protecting the sanctity of the members vote has in the past given the opposing side the opportunity to use coercion factics in getting the other side to forfeit do to the cost to the local.

- 1) If this Local is to be held to its own rules set forth to govern it, under Section 16(A of these Local Union Bylaws, then the nominations meeting would be held on a Saturday mid-afternoon. The majority of the members in this local work Monday-Friday; the mid-afternoon part accommodates those members who are working the graveyard shift Friday night.
- 2) If it's a matter of timeliness, with regards to the notice, then pushing the meeting back 2 days to that Saturday, January 9th, 2021 should also be well within the time needed, as set forth in Article 2 Section 5(a).
- 3) Currently there is a petition in this local to change the date and time of our General Membership Meetings to Saturdays at 10am that Brother Hogue is well aware of, www.change.org/222changethedate
- 4) The use of an "Election Service" and cost associated with it, i believe, will be used to coerce members running for Delegates and Alternates Delegates for the opposing side to fall in line, so as to not "cost the local this unneeded expense." This is not just my belief, this has actually played out with Brother Hogue, and members of his siate, with the opposing slate running against them in this local's last election. See attached statement from Tony Winters, dated Wednesday, September 2nd, 2020, in accordance with Article 5(h) of these Election Rules we feel that this is likely to happen again. This Local has been successful in holding mail-in ballot elections for Shop Stewards in accordance with its own Bylaws, Section 12, and I see no reason the same can't be done for the election of Delegates and Alternate Delegates for this IBT Convention.
- 5) There has been a very large, and not at all subtle, movement for the OZ Slate in this Local, Brother Hogue is backing the Power Slate; the opportunity for Brother Hogue to reach out to any lead members behind the organizing effort of the OZ Slate to coordinate a time the we could go over an election plan before it was submitted was absolutely a possibility. In accordance with Article 2 Section 3(c) Spencer Hogue was notified "on or about June 1st, 2020" with the number of Delegates to be elected by the members of this local, which would have given him more than enough time to set a meeting to discuss dates and times, and the use of an election service. Which would have avoided this exact situation from playing out.

in conclusion, We are requesting that the Office of Elections reject this Local Unions Election Plan. We request that the Office of Elections require for this Delegates Nominations Meeting to be held on Saturday, January 9th, 2021 in the mid-afternoon, or on a Saturday in accordance with Article 2 Section 5(a). Also, we are requesting that the Office of Election approve and accept Local 222's ability to conduct its own mail-in ballot election for the Delegates and Alternate Delegates to the 2021 iBT Convention.

Response to Varney Comments from IBT Local Union 222 Secretary Treasurer Spencer Hogue to Election Office Regional Director Jim Devine

Hello Jim.

My responses are in red and in italicis.

- If this Local is to be held to its own rules set forth to govern it, under Section 16(A of these Local Union Bylaws, then the nominations meeting would be held on a Saturday mid-afternoon. The majority of the members in this local work Monday-Friday; the midafternoon part accommodates those members who are working the gravevard shift Friday night. We represent many members, in many different industries, in a 24/7 economy. We currently have our General Membership schedule alternate each month between the first Tuesday of the month and first Saturday of the month. This enables different groups of members to participate. Participation is not substantially different between the two dates/times. For example: ABF and YRCW (freight) approximately 70% of the bid local and dock workers can make a meeting at 6:00 PM on a Monday. Approximately 70% of our UPS Members can make a meeting at the same time. Almost all of our construction industry can make the meeting as well. These are the three largest groups in our Local, Also, we have large segments (bakery/dairy) that do not have traditional Monday-Friday workweeks. Convenience also carries weight. There will likely be greater participation on a Monday than a Saturday because the membership can plan the meeting into a normally scheduled workday i.e. before/after work instead of committing a day of their weekend. There is no perfect date and time due to the wideranging schedules/industries involved. At the nomination meeting for officers that was held on Monday November 4th, 2019 at 6:00 PM we had more member participation than at any of our General Membership meetings over the last two years. Written nominations, seconds and acceptances will be accepted for those that cannot participate.
- 2. If it's a matter of timeliness, with regards to the notice, then pushing the meeting back 2 days to that Saturday, January 9th, 2021 should also be well within the time needed, as set forth in Article 2 Section 5(a). The Local Union will be publishing its nomination/election notices in the Rocky Mountain Teamster Newsletter. This saves the Local the additional cost of a mailed notice. The absolute latest that the paper will be mailed is December 10, 2020. With the Holidays that fall within the window I worry that an earlier date, although still timely, may affect timely delivery of the notice. The extra days address that concern.
- 3. Currently there is a petition in this local to change the date and time of our General Membership Meetings to Saturdays at 10am that Brother Hogue is well aware of, www.change.org/222changethedate I am aware that the charging party has circulated a petition asking that the meeting dates/times be changed. That petition has garnered the support of 28 unidentified persons (in over a month's time) who may or may not be members of the Union. In weighing the needs and schedules of the all membership I am

hesitant to even acknowledge a petition that, at best has garnered less than one half of one percent of the membership's support. The petition has been posted and reposted many times with solicitations for signatures. We already have every other General Membership meeting on Saturday at 9:00 AM as described above.

- 4. The use of an "Election Service" and cost associated with it. I believe, will be used to coerce members running for Delegates and Alternates Delegates for the opposing side to fail in line, so as to not "cost the local this unneeded expense." This is not just my bellef, this has actually played out with Brother Hogue, and members of his slate, with the opposing state running against them in this local's last election. See attached statement from Tony Winters, dated Wednesday, September 2nd, 2020. In accordance with Article 5(h) of these Election Rules we feel that this is likely to happen again. This Local has been successful in holding mall-in ballot elections for Shop Stewards in accordance with its own Bylaws, Section 12, and I see no reason the same can't be done for the election of Delegates and Alternate Delegates for this IBT Convention. Having an election regardless of how it is conducted is an expensive and timeconsuming endeavor. Many of the expenses such as postage/printing are a fixed cost regardless of who conducts the election. Also, the impact to the membership by the Local Union conducting the entire election would be far greater than an outside agency's fees, because of the need to divert resources that are currently used to service the membership to conducting all facets of an election. Also, the finances of this Local are rock solid. In my six plus years in office we have tripled the Union's assets. The cost of an election is not a financial concern or burden on this Local in any way, Mr. Varney transferred from Local 483 in Idaho in 2019. His experiences with a small financially destitute Local may be the reason for his concern. In fact, he coerced the leadership of that Local to allow him to run unopposed for delegate in the last election to avoid the cost of an election. We do currently conduct elections for stewards by mail. These elections involve small groups of employees from specific bargaining units. The delegates election is a statewide election where every member can vote. Mr. Varney raised no objections in the officer election in 2019 regarding the use of an outside agency. As far as the allegations of coercion go. I am deeply offended that Mr. Winters has made these allegations. Tony was in my office with several others present the week before the nomination meeting when I specifically told him that I didn't care if he ran and that it was his right as a member of the Union and we even verified his eligibility. The information given to Mr. Winters on November 6th, 2019 was simply informational and was done to be fully transparent of the process because he was so disorganized and unprepared for the nomination meeting that it nearly derailed the meeting. He failed to get himself nominated because of his incompetence. I gave him the full set of rules, instructions on how to file protests, copies of the By-Laws and Constitution and TrueBallot's processes that would be used to hold a clean election. Even when specific timelines were laid out on protests, he failed to protest timely, even after I reminded him on November 7th, 2019.
- 5. There has been a very large, and not at all subtle, movement for the OZ State in this Local, Brother Hogue is backing the Power State; the opportunity for Brother Hogue to reach out to any lead members behind the organizing effort of the OZ State to coordinate a time the we could go over an election plan before it was submitted was absolutely a possibility. In accordance with Article 2 Section 3(c) Spencer Hogue was notified "on or about June 1st, 2020" with the number of Delegates to be elected by the members of this local, which would have given him more than enough time to set a meeting to discuss dates and times, and the use of an election service. Which would have avoided

this exact situation from playing out. It is presumptive of Mr. Varney to declare who I am supporting when I have made my position clear to everyone that has asked me (Mr. Varney has not) that I will be voting a split ticket in this election. I support candidates on both sides and there are candidates that I could not in good conscience support on both slates as well. When asked by staff and members about the petition campaign to get candidates accredited, I informed them of the rules and encouraged them to get signatures for whomever they support. In fact, several OZ supporters also gathered signatures for the Power Slate. The two most recent appointments to the Local Union Executive Board are supporting the OZ Slate and this was known to me prior to their appointment. As far as reaching out to an unidentified group's lead members, this would be presumptive on my part. No one has declared to me that they intend to run for delegate or alternate. Mr. Varney has not communicated his intentions to me.
